He is Full Professor of the University (since 2018) teaching in undergraduate, master and doctorate studies. He began his relationship with the University of Seville as an assistant professor in 1992. He is also associated research of the Universidad Autónoma de Chile (Chile) since 2015 at present. Dr Cansino is part of the Project Advisory Board of the project named "Behavioural economics for energy and climate change policies and the transition to a sustainable energy system" funded by ETH-Zurich (Swiss). The main research of this project is Luis Mundaca from THE INTERNATIONAL INSTITUTE FOR INDUSTRIAL ENVIRONMENTAL ECONOMICS (IIIEE)-University of Lund.

Dr Cansino has published near to 30 scientific articles in indexed journals most of them Q1. Articles are mainly focused on the fields of Energy Economics, Environmental Economics, Public Policies Evaluation and Fiscal Policy. He coauthorized 4 book chapter with well indexed editorial. In the field of research, belongs to the research group of Economic Theory and Political Economy. He is the research leader of the Chair of Economics of Energy and

Environment of the University of Seville-Red Eléctrica de España (www.eee-tech.org). It also has 4 research articles in indexed journals included in SCOPUS.

He has co supervised 4 Ph D thesis (with JCR and SCOPUS publications all of them), and currently has another 4 in progress. He has also directed more than 10 thesis' masters, one of them at the University of Lund (Sweden).
